

TRAINING OPPORTUNITIES provided by ICC Region VI

Below are 3 training opportunities that the Region VI Board is offering to aid our membership with very important topics you will encounter. 2 Code related webinars and 1 free class on how to participate the Code Development process.

The 2 primary classes: Nov 14,2025 1-4 PM Onsite Energy Storage Systems and issues associated with the buildings they are installed in. This is being offered by Chief Micheal Obrian who is the leader in the ICC effort to develop standards to address the code issues. This class will give you the details you need to consider when encountering ESS.

Nov 18,2025 1-4 PM The next in our series on Disaster planning for your community. This is intended to help us understand the need and benefits of Mutual Aid and disaster preparedness. A key to your own efforts if your office is directly impacted, this will provide some critical guidance to you before an event hits. Again presented by William Bracken who has developed the ICC Institute program for "When Disaster Strikes". As this continues our series from last year.

Both of the above class registrations links are below and available until NOVEMBER 12 for \$30 each. Registration and payment must be made prior to November 12, 2025. Registration thru WebEx followed by payment thru SQUARE. **IMPORTANT** item for those paying for multiple individuals, you can pay for all at once, but you **must** send a list of the members you paid for to Region VI, with their email addresss (mmoseley@townithacany.gov). If a list of paid members is not provided, the registrations will not be approved and the link to join the webinar will not be provided. All individuals are required to register though WebEx, and pay the fee to receive the webinar link.

Dottie Harris will be your guide to the finer points of using your membership benefits to effect changes to the codes we all work with. This is a great course for new and veteran code officials.
